

**PROPOSED ARIZONA POLLUTANT DISCHARGE ELIMINATION SYSTEM (AZPDES)**

**RENEWAL PERMIT**

Pursuant to the Clean Water Act and in accordance with Arizona Administrative Code (A.A.C.) R18-9-A907, the Director of the Arizona Department of Environmental Quality (ADEQ) proposes to issue an Arizona Pollutant Discharge Elimination System (AZPDES) Permit to discharge pollutants to Waters of the United States to the following applicant, subject to certain effluent limitations and special conditions:

Arizona Public Service Company (APS) applied for a renewal AZPDES permit for the proposed discharge of sanding well water, cooling tower blowdown, and low volume wastes from the West Phoenix Power Plant to a Phoenix Area Canal in the Middle Gila River Basin in Township 1 N, Range 2 E, Section 9, Maricopa County, Arizona. The West Phoenix Power Plant is a multiunit natural gas-fueled electric power generating plant with a combined net output for the discharging units of approximately 365 megawatts.

All written comments received by ADEQ by the close of business on the date 30 days after publication of this notice will be considered in the final permit decision. A public hearing request must be in writing and must include the reasons for such request. If there is a significant degree of public interest, the Director will hold a hearing in accordance with A.A.C. R18-9-A908(B).
