

**PROPOSED ARIZONA POLLUTANT DISCHARGE ELIMINATION SYSTEM (AZPDES)
RENEWAL PERMIT**

Pursuant to the Clean Water Act and in accordance with Arizona Administrative Code (A.A.C.) R18-9-A907, the Director of the Arizona Department of Environmental Quality (ADEQ) proposes to issue an Arizona Pollutant Discharge Elimination System (AZPDES) Permit to discharge pollutants to Waters of the United States to the following applicant, subject to certain effluent limitations and special conditions:

Global Water – Hassayampa Utilities Company, Inc. applied for a renewal AZPDES permit for the proposed discharge of up to 0.55 million gallons per day (mgd) of treated domestic wastewater from the Hassayampa, Balterra Wastewater Reclamation Facility (WRF) to Winter Wash, tributary to Centennial Wash, in the Middle Gila River Basin in Township 2 N, Range 6 W, Section 30, in Maricopa County, Arizona. The Hassayampa, Balterra WRF is a privately-owned treatment works that will receive domestic wastewater from the Unified School District Number 90 community and small commercial sources in Tonopah. The facility has not yet been constructed. The treatment will be secondary treatment with denitrification and UV disinfection with chlorination and dechlorination back-up. Sludge will be hauled offsite to the Southwest Regional Landfill of Buckeye, Arizona.

Persons may submit comments or request a public hearing on the proposed action in writing, to Lesley Davidson, Arizona Department of Environmental Quality, Water Quality Division, 1110 W. Washington St., Phoenix, Arizona 85007, or electronically to Davidson.lesley@azdeq.gov. All written comments received by ADEQ by the close of business on the date 30 days after publication of this notice will be considered in the final permit decision. A public hearing request must be in writing and must include the reasons for such request. If there is a significant degree of public interest, the Director will hold a hearing in accordance with A.A.C. R18-9-A908(B).

ADEQ will take reasonable measures to provide access to department services to individuals with limited ability to speak, write or understand English and/or to those with disabilities.
