

**PROPOSED ARIZONA POLLUTANT DISCHARGE ELIMINATION SYSTEM (AZPDES)
PERMIT MODIFICATION**

Pursuant to the Clean Water Act and in accordance with Arizona Administrative Code (A.A.C.) R18-9-A907, the Director of the Arizona Department of Environmental Quality (ADEQ) proposes to modify an Arizona Pollutant Discharge Elimination System (AZPDES) Permit to discharge pollutants to Waters of the United States to the following applicant, subject to certain effluent limitations and special conditions:

The City of Casa Grande applied for a major modification to their AZPDES permit for the addition of Outfall 002 and the proposed discharge of up to 14 million gallons per day (mgd) of treated domestic wastewater from the Casa Grande Wastewater Reclamation Facility (WRF) to the Santa Cruz Wash and the North Branch of the Santa Cruz Wash in the Santa Cruz River Basin in Township 6 S, Range 5 E, Sections 12 and 21, in Pinal County, Arizona. The Casa Grande WRF is a publicly owned treatment works that receives domestic wastewater from residential, commercial, and industrial sources in Casa Grande. Sludge is sent to the City of Casa Grande Landfill for disposal.

The draft permit and statement of basis were published in the *Arizona Business Gazette* on March 2, 2023. Due to substantive changes made to the draft permit and statement of basis, ADEQ is extending the public comment period by 30 days.

Persons may submit comments or request a public hearing on the proposed action in writing, to Rachel Heinz, Arizona Department of Environmental Quality, Water Quality Division, 1110 W. Washington St., Phoenix, Arizona 85007, or electronically to heinz.rachel@azdeq.gov. All written comments received by ADEQ by the close of business on the date 30 days after publication of this notice will be considered in the final permit decision. A public hearing request must be in writing and must include the reasons for such request. If there is a significant degree of public interest, the Director will hold a hearing in accordance with A.A.C. R18-9-A908(B).

ADEQ will take reasonable measures to provide access to department services to individuals with limited ability to speak, write or understand English and/or to those with disabilities.
