PROPOSED ARIZONA POLLUTANT DISCHARGE ELIMINATION SYSTEM (AZPDES)

NEW PERMIT

Pursuant to the Clean Water Act and in accordance with Arizona Administrative Code (A.A.C.) R18-9-A907, the Director of the Arizona Department of Environmental Quality (ADEQ) proposes to issue an Arizona Pollutant Discharge Elimination System (AZPDES) Permit to discharge pollutants to Waters of the United States to the following applicant, subject to certain effluent limitations and special conditions:

City of Phoenix applied for a renewal AZPDES permit for the proposed discharge of up to 8 million gallons per day (mgd) of treated domestic wastewater from the Cave Creek Water Reclamation Plant (WRP) to an unnamed wash, tributary to Cave Creek in the Middle Gila River River Basin in Township 4 N, Range 3 E, Section 14, in Maricopa County, Arizona. The Cave Creek WRP is a publicly owned treatment works that receives domestic wastewater from residential, commercial, and industrial sources in Phoenix, AZ. Sludge is transported to the 91st Avenue Wastewater Treatment Plant that provides treatment and disposal.

Persons may submit comments or request a public hearing on the proposed action in writing, to Julia Rowe, Arizona Department of Environmental Quality, Water Quality Division, 1110 W. All written comments received by ADEQ by the close of business on the date 30 days after publication of this notice will be considered in the final permit decision. A public hearing request must be in writing and must include the reasons for such request. If there is a significant degree of public interest, the Director will hold a hearing in accordance with A.A.C. R18-9-A908(B).
