

PROPOSED ARIZONA POLLUTANT DISCHARGE ELIMINATION SYSTEM (AZPDES) RENEWAL PERMIT

Pursuant to the Clean Water Act and in accordance with Arizona Administrative Code (A.A.C.) R18-9-A907, the Director of the Arizona Department of Environmental Quality (ADEQ) proposes to issue an Arizona Pollutant Discharge Elimination System (AZPDES) Permit to discharge pollutants to Waters of the United States to the following applicant, subject to certain effluent limitations and special conditions:

ADEQ applied for the renewal of an AZPDES permit for the proposed discharge of treated groundwater from the Central Tucson PFAS Project Demonstration Facility to the Santa Cruz River in the Santa Cruz Watershed in Township 14 S, Range 14 E, Section 22, in Pima County, Arizona. The Central Tucson PFAS Project Demonstration Facility is a groundwater remediation facility in Tucson, Arizona. ADEQ is conducting the Central Tucson PFAS Project Pilot Test at a former Tucson Water production well site (C-007A) to demonstrate long-term performance of ion exchange treatment for the removal of per and polyfluoroalkyl substances (PFAS) from impact groundwater.

Persons may submit comments or request a public hearing on the proposed action in writing, to Swathi Kasanneni, Arizona Department of Environmental Quality, Water Quality Division, 1110 W. Washington St., Phoenix, Arizona 85007, or electronically to kasanneni.swathi@azdeq.gov. All written comments received by ADEQ by the close of business on the date 30 days after publication of this notice will be considered in the final permit decision. A public hearing request must be in writing and must include the reasons for such request. If there is a significant degree of public interest, the Director will hold a hearing in accordance with A.A.C. R18-9-A908(B).

ADEQ will take reasonable measures to provide access to department services to individuals with limited ability to speak, write or understand English and/or to those with disabilities.
