## PROPOSED ARIZONA POLLUTANT DISCHARGE ELIMINATION SYSTEM (AZPDES) RENEWAL PERMIT

Pursuant to the Clean Water Act and in accordance with Arizona Administrative Code (A.A.C.) R18-9-A907, the Director of the Arizona Department of Environmental Quality (ADEQ) proposes to issue an Arizona Pollutant Discharge Elimination System (AZPDES) Permit to discharge pollutants to Waters of the United States to the following applicant, subject to certain effluent limitations and special conditions:

ADOC applied for a renewal AZPDES permit for the proposed discharge of up to 0.925 million gallons per day (mgd) of treated domestic wastewater from the Arizona Department of Corrections (ADOC)/Arizona State Prison Complex (ASPC) Eyman Wastewater Treatment Plant to the Gila River in the Middle Gila River Basin in Township 4 S, Range 10 E, Section 20, in Pinal County, Arizona. The ASPC Eyman Wastewater Treatment Plant is a publicly owned treatment works that receives domestic wastewater from residential sources in Florence. Sludge is stabilized in primary and secondary digesters and dried in drying beds before landfill disposal.

All written comments received by ADEQ by the close of business on the date 30 days after publication of this notice will be considered in the final permit decision. A public hearing request must be in writing and must include the reasons for such request. If there is a significant degree of public interest, the Director will hold a hearing in accordance with A.A.C. R18-9-A908(B).
