## PROPOSED ARIZONA POLLUTANT DISCHARGE ELIMINATION SYSTEM (AZPDES) RENEWAL PERMIT

Pursuant to the Clean Water Act and in accordance with Arizona Administrative Code (A.A.C.) R18-9-A907, the Director of the Arizona Department of Environmental Quality (ADEQ) proposes to issue an Arizona Pollutant Discharge Elimination System (AZPDES) Permit to discharge pollutants to Waters of the United States to the following applicant, subject to certain effluent limitations and special conditions:

Fiver Rivers Cattle Feeding, LLC has applied for renewal of an Arizona Pollutant Discharge Elimination System (AZPDES) permit for operation of a concentrated animal feeding operation (CAFO) located 4.7 miles east of Wellton and one mile north of Highway 8 in Yuma County, Arizona. The facility operation generates approximately 142,505 tons or 4,786,750 gallons of manure, litter, and process wastewater annually.

Persons may submit comments or request a public hearing on the proposed action in writing, to Julia A Rowe, Arizona Department of Environmental Quality, Water Quality Division, 1110 W. Washington St., Phoenix, Arizona 85007, or electronically to <a href="mailto:rowe.julia@azdeq.gov">rowe.julia@azdeq.gov</a>. All written comments received by ADEQ by the close of business on the date 30 days after publication of this notice will be considered in the final permit decision. A public hearing request must be in writing and must include the reasons for such request. If there is a significant degree of public interest, the Director will hold a hearing in accordance with A.A.C. R18-9-A908(B).

ADEQ will take reasonable measures to provide access to department services to individuals with limited ability to speak, write or understand English and/or to those with disabilities.
