

**PROPOSED ARIZONA POLLUTANT DISCHARGE ELIMINATION SYSTEM (AZPDES)**

**RENEWAL PERMIT**

Pursuant to the Clean Water Act and in accordance with Arizona Administrative Code (A.A.C.) R18-9-A907, the Director of the Arizona Department of Environmental Quality (ADEQ) proposes to issue an Arizona Pollutant Discharge Elimination System (AZPDES) Permit to discharge pollutants to Waters of the United States to the following applicant, subject to certain effluent limitations and special conditions:

Freeport-McMoRan Miami, Inc., Pinal Creek Project applied for a renewal AZPDES permit for the proposed discharge of up to 9.36 million gallons per day (MGD) of treated groundwater from the Lower Pinal Creek Water Treatment Plant (LPCWTP) to the Pinal Creek, tributary to the Salt River, in the Salt River Basin in Township 2 N, Range 15 E, Section 18, in Gila County, Arizona. The LPCWTP is operated as a remedial action at the Pinal Creek Water Quality Assurance Revolving Fund (WQARF) site.

All written comments received by ADEQ by the close of business on the date 30 days after publication of this notice will be considered in the final permit decision. A public hearing request must be in writing and must include the reasons for such request. If there is a significant degree of public interest, the Director will hold a hearing in accordance with A.A.C. R18-9-A908(B).
