

**PROPOSED ARIZONA POLLUTANT DISCHARGE ELIMINATION SYSTEM (AZPDES)
RENEWAL PERMIT**

Pursuant to the Clean Water Act and in accordance with Arizona Administrative Code (A.A.C.) R18-9-A907, the Director of the Arizona Department of Environmental Quality (ADEQ) proposes to issue an Arizona Pollutant Discharge Elimination System (AZPDES) Permit to discharge pollutants to Waters of the United States to the following applicant, subject to certain effluent limitations and special conditions:

United States Department of Interior, National Park Service, Grand Canyon National Park (Grand Canyon National Park) applied for a renewal AZPDES permit for the proposed discharge of up to 0.15 million gallons per day (mgd) of treated domestic wastewater from the North Rim Wastewater Treatment Plant (WWTP) to the Transcept Canyon in the Colorado-Grand Canyon River Basin in Township 33N, Range 3E, Section 34, in Coconino County, Arizona. The WWTP is a federally owned treatment works that receives domestic wastewater from residential and commercial sources from the North Rim of the Grand Canyon National Park, including the visitor center, lodging, restaurant, campground, laundry, and maintenance. Sludge is dried and transported by truck to an off-site storage lagoon at the South Rim biosolids disposal site.

Persons may submit comments or request a public hearing on the proposed action in writing, to Mindi Cross, Arizona Department of Environmental Quality, Water Quality Division, 1110 W. Washington St., Phoenix, Arizona 85007, or electronically to cross.mindi@azdeq.gov. All written comments received by ADEQ by the close of business on the date 30 days after publication of this notice will be considered in the final permit decision. A public hearing request must be in writing and must include the reasons for such request. If there is a significant degree of public interest, the Director will hold a hearing in accordance with A.A.C. R18-9-A908(B).

ADEQ will take reasonable measures to provide access to department services to individuals with limited ability to speak, write or understand English and/or to those with disabilities.
