## PROPOSED ARIZONA POLLUTANT DISCHARGE ELIMINATION SYSTEM (AZPDES) RENEWAL PERMIT

Pursuant to the Clean Water Act and in accordance with Arizona Administrative Code (A.A.C.) R18-9-A907, the Director of the Arizona Department of Environmental Quality (ADEQ) proposes to issue an Arizona Pollutant Discharge Elimination System (AZPDES) Permit to discharge pollutants to Waters of the United States to the following applicant, subject to certain effluent limitations and special conditions:

City of Mesa Water Resources applied for a renewal AZPDES permit for the proposed discharge of up to 30 million gallons per day (MGD) of treated domestic wastewater from the Greenfield Water Reclamation Plant (GWRP) to the East Maricopa Floodway, tributary to the Gila River in the Middle Gila River Basin in Township 2 S, Range 6 E, Section 15, in Maricopa County, Arizona. The GWRP is a publicly owned treatment works that receives domestic wastewater from residential, commercial, and industrial sources in the City of Mesa and Towns of Queen Creek, and Gilbert. Sludge is treated on-site and then either hauled by a licensed contractor to a landfill or land applied as Class B Biosolids.

Persons may submit comments or request a public hearing on the proposed action in writing, to Lesley Davidson, Arizona Department of Environmental Quality, Water Quality Division, 1110 W. All written comments received by ADEQ by the close of business on the date 30 days after publication of this notice will be considered in the final permit decision. A public hearing request must be in writing and must include the reasons for such request. If there is a significant degree of public interest, the Director will hold a hearing in accordance with A.A.C. R18-9-A908(B).
