

PROPOSED ARIZONA POLLUTANT DISCHARGE ELIMINATION SYSTEM (AZPDES)

NEW PERMIT FOR EXISTING FACILITY

Pursuant to the Clean Water Act and in accordance with Arizona Administrative Code (A.A.C.) R18-9-A907, the Director of the Arizona Department of Environmental Quality (ADEQ) proposes to issue an Arizona Pollutant Discharge Elimination System (AZPDES) Permit to discharge pollutants to Waters of the United States to the following applicant, subject to certain effluent limitations and special conditions:

United States Department of Interior – The National Park Service applied for a Individual AZPDES permit for the proposed discharge of up to 1.25 million gallons per day (MGD) of treated chlorinated groundwater from the Havasupai Garden Potable Water Pump station to Garden Creek in the Grand Canyon River Basin in Coconino County, Arizona. The Havasupai Garden Potable Water Pump Station is a federally-owned potable water pumping station and is considered to be a minor industrial facility under the AZPDES program.

Persons may submit comments or request a public hearing on the proposed action in writing, to Lora Walsh Arizona Department of Environmental Quality, Water Quality Division, 1110 W. Washington St., Phoenix, Arizona 85007, or electronically to walsh.lora@azdeq.gov. All written comments received by ADEQ by the close of business on the date 30 days after publication of this notice will be considered in the final permit decision. A public hearing request must be in writing and must include the reasons for such request. If there is a significant degree of public interest, the Director will hold a hearing in accordance with A.A.C. R18-9-A908(B).

ADEQ will take reasonable measures to provide access to department services to individuals with limited ability to speak, write or understand English and/or to those with disabilities.
