

**PROPOSED ARIZONA POLLUTANT DISCHARGE ELIMINATION SYSTEM (AZPDES)
RENEWAL PERMIT**

Pursuant to the Clean Water Act and in accordance with Arizona Administrative Code (A.A.C.) R18-9-A907, the Director of the Arizona Department of Environmental Quality (ADEQ) proposes to issue an Arizona Pollutant Discharge Elimination System (AZPDES) Permit to discharge pollutants to Waters of the United States to the following applicant, subject to certain effluent limitations and special conditions:

The U.S. Department of the Interior, Bureau of Reclamation applied for a renewal AZPDES permit for the proposed discharge of up to 0.061 million gallons per day (mgd) of treated domestic wastewater and filter backwash water from the Hoover Dam Wastewater Treatment Plant and Water Treatment Plant (WWTP/WTP) to the Colorado River in the Colorado – Lower Gila River Basin River Basin in Township 30 N, Range 23 W, Section 3, in Mohave County, Arizona. The Hoover Dam WWTP is a federally-owned treatment works that treats domestic wastewater generated by tourists and employees mixed with filter rinse and backwash water from the WTP. The physical address of the facility is in Boulder City, Nevada however the outfall discharges in Arizona. Sludge is disposed of at two drying beds located on-site for long-term storage prior to landfill disposal.

Persons may submit comments or request a public hearing on the proposed action in writing, to Corin Hammond, Arizona Department of Environmental Quality, Water Quality Division, 1110 W. Washington St., Phoenix, Arizona 85007, or electronically to hammond.corin@azdeq.gov. All written comments received by ADEQ by the close of business on the date 30 days after publication of this notice will be considered in the final permit decision. A public hearing request must be in writing and must include the reasons for such request. If there is a significant degree of public interest, the Director will hold a hearing in accordance with A.A.C. R18-9-A908(B).

ADEQ will take reasonable measures to provide access to department services to individuals with limited ability to speak, write or understand English and/or to those with disabilities.
