

**PROPOSED ARIZONA POLLUTANT DISCHARGE ELIMINATION SYSTEM (AZPDES)**

**PERMIT RENEWAL**

Pursuant to the Clean Water Act and in accordance with Arizona Administrative Code (A.A.C.) R18-9-A907, the Director of the Arizona Department of Environmental Quality (ADEQ) proposes to issue an Arizona Pollutant Discharge Elimination System (AZPDES) Permit to discharge pollutants to Waters of the United States to the following applicant, subject to certain effluent limitations and special conditions:

Pima County applied for a renewal AZPDES permit for the proposed discharge of up to 0.015 million gallons per day (MGD) of treated domestic wastewater from the Mount Lemmon WRF to an unnamed wash listed in Arizona Administrative Code R18-11 Appendix B in the San Pedro – Willcox Playa – Rio Yaqui River Basin at Outfall 001 Township 11 S, Range 16 E, Section 30, Outfall 002 Township 11 S, Range 16 E, Section 30, and Outfall 003 Township 11 S, Range 16 E, Section 30 in Pima County, Arizona. The Mount Lemmon WRF is a publicly-owned treatment works that receives domestic wastewater from residential and commercial sources in Summerhaven. Sludge is transported offsite via truck to Tres Rios WRF.

All written comments received by ADEQ by the close of business on the date 30 days after publication of this notice will be considered in the final permit decision. A public hearing request must be in writing and must include the reasons for such request. If there is a significant degree of public interest, the Director will hold a hearing in accordance with A.A.C. R18-9-A908(B).
