

PROPOSED ARIZONA POLLUTANT DISCHARGE ELIMINATION SYSTEM (AZPDES)

RENEWAL PERMIT FOR NEW FACILITY

Pursuant to the Clean Water Act and in accordance with Arizona Administrative Code (A.A.C.) R18-9-A907, the Director of the Arizona Department of Environmental Quality (ADEQ) proposes to issue an Arizona Pollutant Discharge Elimination System (AZPDES) Permit to discharge pollutants to Waters of the United States to the following applicant, subject to certain effluent limitations and special conditions:

United States Department of Interior (USDOI), National Park Service (NPS) applied for a renewal AZPDES permit for the proposed discharge of up to 0.060 million gallons per day (MGD) of treated domestic wastewater from the North Rim WWTP to Transept Canyon in the Colorado Grand Canyon River Basin in Township 33 N, Range 3 E, Section 34, in Coconino County, Arizona. The North Rim WWTP is a federally-owned treatment works that receives domestic wastewater from residential and commercial sources from the North Rim of the Grand Canyon. Sludge dried in beds on-site prior to transport to the South Rim WWTP for final composting, blending, and land application.

Persons may submit comments or request a public hearing on the proposed action in writing, to Lora Walsh, Arizona Department of Environmental Quality, Water Quality Division, 1110 W. Washington St., Phoenix, Arizona 85007, or electronically to walsh.lora@azdeq.gov. All written comments received by ADEQ by the close of business on the date 30 days after publication of this notice will be considered in the final permit decision. A public hearing request must be in writing and must include the reasons for such request. If there is a significant degree of public interest, the Director will hold a hearing in accordance with A.A.C. R18-9-A908(B).

ADEQ will take reasonable measures to provide access to department services to individuals with limited ability to speak, write or understand English and/or to those with disabilities. Requests for language translation, ASL
