## PROPOSED ARIZONA POLLUTANT DISCHARGE ELIMINATION SYSTEM (AZPDES) PERMIT MODIFICATION

Pursuant to the Clean Water Act and in accordance with Arizona Administrative Code (A.A.C.) R18-9-A907, the Director of the Arizona Department of Environmental Quality (ADEQ) proposes to modify an Arizona Pollutant Discharge Elimination System (AZPDES) Permit to discharge pollutants to Waters of the United States to the following applicant, subject to certain effluent limitations and special conditions:

Arizona Department of Environmental Quality (ADEQ)—Waste Programs Division (WPD) requested an AZPDES permit modification for the proposed discharge of up to 0.1728 million gallons per day (mgd) of treated groundwater from the Former Perryville Feed Store Leaking Underground Storage Tank (UST) Site Groundwater Treatment System (GWTS) to the Roosevelt Irrigation District (RID) Canal in the Middle Gila River Basin in Township 1 N, Range 2 W, Section 15, in Maricopa County, Arizona. The Former Perryville Feed Store Leaking UST Site GWTS is a groundwater remediation facility designed to pump-and-treat groundwater contaminated with petroleum hydrocarbons in Goodyear.

Persons may submit comments or request a public hearing on the proposed action in writing, to Rachel Heinz, Arizona Department of Environmental Quality, Water Quality Division, 1110 W. Washington St., Phoenix, Arizona 85007, or electronically to heinz.rachel@azdeq.gov. All written comments received by ADEQ by the close of business on the date 30 days after publication of this notice will be considered in the final permit decision. A public hearing request must be in writing and must include the reasons for such request. If there is a significant degree of public interest, the Director will hold a hearing in accordance with A.A.C. R18-9-A908(B).

ADEQ will take reasonable measures to provide access to department services to individuals with limited ability to speak, write or understand English and/or to those with disabilities.
