

## **PROPOSED ARIZONA POLLUTANT DISCHARGE ELIMINATION SYSTEM (AZPDES) PERMIT MODIFICATION**

Pursuant to the Clean Water Act and in accordance with Arizona Administrative Code (A.A.C.) R18-9-A907, the Director of the Arizona Department of Environmental Quality (ADEQ) proposes to issue an Arizona Pollutant Discharge Elimination System (AZPDES) Permit to discharge pollutants to Waters of the United States to the following applicant, subject to certain effluent limitations and special conditions:

The Arizona State Parks Board applied for an AZPDES permit modification for the proposed discharge of up to 0.025 million gallons per day (MGD) of treated domestic wastewater from the Patagonia Lake State Park Wastewater Treatment Plant (WWTP) to Patagonia Lake in the Santa Cruz River Basin in Township 22 S, Range 15 E, Section 30, in Santa Cruz County, Arizona. The Patagonia Lake State Park WWTP is a publicly-owned treatment works that receives domestic wastewater from Patagonia Lake State Park. Sludge is stored in an aerated sludge chamber and hauled offsite for disposal.

Persons may submit comments or request a public hearing on the proposed action in writing, to Rachael Willis, Arizona Department of Environmental Quality, Water Quality Division, 1110 W. Washington St., Phoenix, Arizona 85007, or electronically to [willis.rachael@azdeq.gov](mailto:willis.rachael@azdeq.gov). All written comments received by ADEQ by the close of business on the date 30 days after publication of this notice will be considered in the final permit decision. A public hearing request must be in writing and must include the reasons for such request. If there is a significant degree of public interest, the Director will hold a hearing in accordance with A.A.C. R18-9-A908(B).
