

**PROPOSED ARIZONA POLLUTANT DISCHARGE ELIMINATION SYSTEM (AZPDES)  
RENEWAL PERMIT**

Pursuant to the Clean Water Act and in accordance with Arizona Administrative Code (A.A.C.) R18-9-A907, the Director of the Arizona Department of Environmental Quality (ADEQ) proposes to issue an Arizona Pollutant Discharge Elimination System (AZPDES) Permit to discharge pollutants to Waters of the United States to the following applicant, subject to certain effluent limitations and special conditions:

City of Phoenix applied for a renewal AZPDES permit for the proposed discharge of up to 3.62 million gallons per day (mgd) of groundwater from five supply wells to provide water for wetland ponds and irrigation of native plants within the Rio Salado Habitat Restoration Area. The Rio Salado Habitat Restoration Area is a 595-acre riparian habitat restoration project that extends 5 miles along the Salt River between 19th Avenue and 28th Street in Phoenix, Maricopa County, Arizona. The receiving water is the Salt River in the Middle Gila River Basin. The discharge locations are in Township 1 N, Range 3 E, Sections 17, 20, and 22.

Persons may submit comments or request a public hearing on the proposed action in writing, to Rachel Heinz, Arizona Department of Environmental Quality, Water Quality Division, 1110 W. Washington St., Phoenix, Arizona 85007, or electronically to [heinz.rachel@azdeq.gov](mailto:heinz.rachel@azdeq.gov). All written comments received by ADEQ by the close of business on the date 30 days after publication of this notice will be considered in the final permit decision. A public hearing request must be in writing and must include the reasons for such request. If there is a significant degree of public interest, the Director will hold a hearing in accordance with A.A.C. R18-9-A908(B).

ADEQ will take reasonable measures to provide access to department services to individuals with limited ability to speak, write or understand English and/or to those with disabilities.
