

PROPOSED ARIZONA POLLUTANT DISCHARGE ELIMINATION SYSTEM (AZPDES)

RENEWAL PERMIT

Pursuant to the Clean Water Act and in accordance with Arizona Administrative Code (A.A.C.) R18-9-A907, the Director of the Arizona Department of Environmental Quality (ADEQ) proposes to issue an Arizona Pollutant Discharge Elimination System (AZPDES) Permit to discharge pollutants to Waters of the United States to the following applicant, subject to certain effluent limitations and special conditions:

City of Somerton applied for a renewal AZPDES permit for the proposed discharge of up to 1.8 million gallons per day (mgd) of treated domestic wastewater from the Somerton Wastewater Treatment Plant to the Yuma Main Drain in the Colorado River Basin in Township 10 S, Range 24 W, Section 4, in Yuma County, Arizona. The Somerton Wastewater Treatment Plant is a publicly owned treatment works that receives domestic wastewater from residential sources in Somerton. Sludge is handled by a dewatering screw press and treated to Class B biosolids. Biosolids are sent to AgTech for land application in Somerton, Arizona.

Persons may submit comments or request a public hearing on the proposed action in writing, to Julia Rowe, Arizona Department of Environmental Quality, Water Quality Division, 1110 W. Washington St., Phoenix, Arizona 85007, or electronically to rowe.julia@azdeq.gov. All written comments received by ADEQ by the close of business on the date 30 days after publication of this notice will be considered in the final permit decision. A public hearing request must be in writing and must include the reasons for such request. If there is a significant degree of public interest, the Director will hold a hearing in accordance with A.A.C. R18-9-A908(B).

ADEQ will take reasonable measures to provide access to department services to individuals with limited ability to speak, write or understand English and/or to those with disabilities. Requests for language
