PROPOSED ARIZONA POLLUTANT DISCHARGE ELIMINATION SYSTEM (AZPDES) RENEWAL PERMIT

Salt River Project (SRP) operates the Santan Generating Station (Santan), a steam power electric generating plant in Gilbert, Arizona. SRP applied for a renewal AZPDEs permit for the discharge of cooling tower blowdown, heat recovery steam generator blowdown, other low volume wastes, stormwater, and non-process raw water from the Santan Generating Station located at 1005 South Val Vista Drive to SRP Lateral 4-8.4, SRP Lateral 5-9.0 and SRP Lateral 5-9.5 to the Western Canal (a Phoenix Area Canal) or to SRP Lateral 4-11.4 and SRP Lateral 5-11.0 to an ADOT stormwater drainage system and eventual tributary to the Salt River in the Middle Gila River Basin in Township 1 S, Range 6 E, Section 21 in Maricopa County.

All written comments received by ADEQ by the close of business on the date 30 days after publication of this notice will be considered in the final permit decision. A public hearing request must be in writing and must include the reasons for such request. If there is a significant degree of public interest, the Director will hold a hearing in accordance with A.A.C. R18-9-A908(B).
