

**PROPOSED ARIZONA POLLUTANT DISCHARGE ELIMINATION SYSTEM (AZPDES)
RENEWAL PERMIT**

Pursuant to the Clean Water Act and in accordance with Arizona Administrative Code (A.A.C.) R18-9-A907, the Director of the Arizona Department of Environmental Quality (ADEQ) proposes to issue an Arizona Pollutant Discharge Elimination System (AZPDES) Permit to discharge pollutants to Waters of the United States to the following applicant, subject to certain effluent limitations and special conditions:

The Town of Superior applied for a renewal AZPDES permit for the proposed discharge of up to 0.75 million gallons per day (mgd) of treated domestic wastewater from the Town of Superior Wastewater Treatment Plant (WWTP) to Queen Creek and an unnamed wash, tributary to Queen Creek, in the Middle Gila River Basin in Township 2 S, Range 12 E, Sections 3 and 4, in Pinal County, Arizona. The Town of Superior WWTP is a publicly owned treatment works that receives domestic wastewater from residential, commercial, and industrial sources in Superior, AZ. Sludge is stabilized in a digester and then placed in sludge drying beds prior to being hauled off-site for landfill disposal.

Persons may submit comments or request a public hearing on the proposed action in writing, to Rachel Heinz, Arizona Department of Environmental Quality, Water Quality Division, 1110 W. Washington St., Phoenix, Arizona 85007, or electronically to heinz.rachel@azdeq.gov. All written comments received by ADEQ by the close of business on the date 30 days after publication of this notice will be considered in the final permit decision. A public hearing request must be in writing and must include the reasons for such request. If there is a significant degree of public interest, the Director will hold a hearing in accordance with A.A.C. R18-9-A908(B).

ADEQ will take reasonable measures to provide access to department services to individuals with limited ability to speak, write or understand English and/or to those with disabilities.
