

PROPOSED ARIZONA POLLUTANT DISCHARGE ELIMINATION SYSTEM (AZPDES) RENEWAL PERMIT

Pursuant to the Clean Water Act and in accordance with Arizona Administrative Code (A.A.C.) R18-9-A907, the Director of the Arizona Department of Environmental Quality (ADEQ) proposes to issue an Arizona Pollutant Discharge Elimination System (AZPDES) Permit to discharge pollutants to Waters of the United States to the following applicant, subject to certain effluent limitations and special conditions:

The Virgin River Domestic Wastewater Improvement District (DWID) applied for a renewal AZPDES permit for the proposed discharge of up to 0.0366 million gallons per day (MGD) of treated domestic wastewater from the Virgin River DWID Wastewater Treatment Plant (WWTP) to the Virgin River in the Colorado–Grand Canyon River Basin in Township 40N, Range 15W, Section 05, in Mohave County, Arizona. The Virgin River DWID WWTP is a publicly-owned treatment works that receives domestic wastewater from residential and commercial sources in Beaver Dam. Sludge is hauled via tank truck to the Mesquite WWTP for additional processing and final disposal.

Persons may submit comments or request a public hearing on the proposed action in writing, to Rachael Willis, Arizona Department of Environmental Quality, Water Quality Division, 1110 W. Washington St., Phoenix, Arizona 85007, or electronically to willis.rachael@azdeq.gov. All written comments received by ADEQ by the close of business on the date 30 days after publication of this notice will be considered in the final permit decision. A public hearing request must be in writing and must include the reasons for such request. If there is a significant degree of public interest, the Director will hold a hearing in accordance with A.A.C. R18-9-A908(B).

ADEQ will take reasonable measures to provide access to department services to individuals with limited ability to speak, write or understand English and/or to those with disabilities.
