

PROPOSED ARIZONA POLLUTANT DISCHARGE ELIMINATION SYSTEM (AZPDES)

PERMIT MODIFICATION

Pursuant to the Clean Water Act and in accordance with Arizona Administrative Code (A.A.C.) R18-9-A907, the Director of the Arizona Department of Environmental Quality (ADEQ) proposes to issue an Arizona Pollutant Discharge Elimination System (AZPDES) Permit to discharge pollutants to Waters of the United States to the following applicant, subject to certain effluent limitations and special conditions:

City of Yuma applied for an AZPDES permit modification for the proposed discharge of up to 12 million gallons per day (MGD) of treated domestic wastewater from the Figueroa Avenue WPCF to the Paradise Cove Wetland in the Lower Gila River Basin in Township 16 S, Range 22 E, Section 28, in Yuma County, Arizona. The Figueroa Avenue WPCF is a publicly-owned treatment works that receives domestic wastewater from residential and commercial sources in Yuma. Sludge is stabilized in an aerobic digester and then thickened and then hauled for agricultural land application by an independent contractor.

Persons may submit comments or request a public hearing on the proposed action in writing, to Benjamin Karls, Arizona Department of Environmental Quality, Water Quality Division, 1110 W. Washington St., Phoenix, Arizona 85007, or electronically to karls.benjamin@azdeq.gov. All written comments received by ADEQ by the close of business on the date 30 days after publication of this notice will be considered in the final permit decision. A public hearing request must be in writing and must include the reasons for such request. If there is a significant degree of public interest, the Director will hold a hearing in accordance with A.A.C. R18-9-A908(B).

ADEQ will take reasonable measures to provide access to department services to individuals with limited ability to speak, write or understand English and/or to those with disabilities.
