

**PROPOSED ARIZONA POLLUTANT DISCHARGE ELIMINATION SYSTEM (AZPDES)
RENEWAL PERMIT**

Pursuant to the Clean Water Act and in accordance with Arizona Administrative Code (A.A.C.) R18-9-A907, the Director of the Arizona Department of Environmental Quality (ADEQ) proposes to issue an Arizona Pollutant Discharge Elimination System (AZPDES) Permit to discharge pollutants to Waters of the United States to the following applicant, subject to certain effluent limitations and special conditions:

The Arizona Game & Fish Department applied for a renewal AZPDES permit for the rate of up to 2.74 million gallons per day (mgd) of stream flow through from the Tonto Creek Fish Hatchery (TCFH) to an unnamed tributary in the Salt River Basin in Township 12 N, Range 12 E, Section 33, in Gila County, Arizona. The TCFH is a publicly owned flow-through hatchery with no treatment processes. TCFH obtains water from a natural spring and discharges process water from hatchery operations with no domestic wastewater or industrial components.

Persons may submit comments or request a public hearing on the proposed action in writing, to Jacqueline Maye, Arizona Department of Environmental Quality, Water Quality Division, 1110 W. Washington St., Phoenix, Arizona 85007, or electronically to jpm@azdeq.gov. All written comments received by ADEQ by the close of business on the date 30 days after publication of this notice will be considered in the final permit decision. A public hearing request must be in writing and must include the reasons for such request. If there is a significant degree of public interest, the Director will hold a hearing in accordance with A.A.C. R18-9-A908(B).

ADEQ will take reasonable measures to provide access to department services to individuals with limited ability to speak, write, or understand English and/or to those with disabilities.
