Pursuant to the A.A.C. R18-8-271.I (D)(1)(vii), a copy of the Arizona Hazardous Waste Management Act (AHWMA) and federal Resource Conservation and Recovery Act (RCRA) permit application, draft permit, and additional relevant documents must be made available for public review during the public comment period for the above-referenced facility. This collection of documents will be hereinafter referred to as the "Administrative Record."

The Administrative Record includes documents in the Triumvirate Environmental (Arizona), Inc. correspondence files in Arizona Department of Environmental Quality's (ADEQ's) Records Center, as well as other documents generally available to the public through ADEQ or the United States Environmental Protection Agency (U.S. EPA). These documents are either attached or may be incorporated by reference. As noted below, other records on this facility may be found at the ADEQ Records Center Office, 1110 West Washington Street, Phoenix, Arizona; Monday through Friday from 8:30 a.m. to 4:30 p.m., excluding state holidays.
