REQUEST FOR NO FURTHER ACTION DETERMINATION**

Pro Petroleum, Inc. has submitted a request for a No Further Action (NFA) determination to the Arizona Department of Environmental Quality (ADEQ) Voluntary Remediation Program (VRP) for the Pro Petroleum, Inc. VRP site. The NFA requests closure for soil and groundwater and was submitted in accordance with Arizona Revised Statutes § 49-181.

The Pro Petroleum, Inc. VRP site consists of a petroleum diesel terminal located in Phoenix, Arizona. Contaminants of concern at the site are petroleum related constituents for soil and groundwater.
