

**PROPOSED ARIZONA POLLUTANT DISCHARGE ELIMINATION SYSTEM (AZPDES)
RENEWAL PERMIT**

Pursuant to the Clean Water Act and in accordance with Arizona Administrative Code (A.A.C.) R18-9-A907, the Director of the Arizona Department of Environmental Quality (ADEQ) proposes to issue an Arizona Pollutant Discharge Elimination System (AZPDES) Permit to discharge pollutants to Waters of the United States to the following applicant, subject to certain effluent limitations and special conditions:

City of Phoenix – Parks and Recreation Department applied for a renewal AZPDES permit for the proposed discharge of up to approximately 3.62 million gallons per day (mgd) of groundwater from five supply wells to provide a river ecosystem to achieve a sustainable balance of flora and fauna at the Rio Salado Habitat Restoration Area. This facility consists of a 595-acre park located along a 5-mile section of the Salt River south of downtown Phoenix, in Maricopa County, Arizona. The receiving water is the Salt River, from the Interstate 10 Bridge to the 23rd Avenue Wastewater Treatment Plant, in the Middle Gila River Basin. The points of discharge are in Township 1 N, Range 3 E, Sections 17, 19, 20, and 22.

Persons may submit comments or request a public hearing on the proposed action in writing, to Andy Koester, Arizona Department of Environmental Quality, Water Quality Division, 1110 W. Washington St., Phoenix, Arizona 85007, or electronically to ak5@azdeq.gov. All written comments received by ADEQ by the close of business on the date 30 days after publication of this notice will be considered in the final permit decision. A public hearing request must be in writing and must include the reasons for such request. If there is a significant degree of public interest, the Director will hold a hearing in accordance with A.A.C. R18-9-A908(B).
