

PUBLIC NOTICE

YOU HAVE A VOICE IN AIR POLLUTION CONTROL IN ARIZONA

The Arizona Department of Environmental Quality (ADEQ) proposes to issue Air Quality Control Significant Revision Permit No. 66329 to ASARCO LLC for the installation and operation of a new acid plant preheater at the ASARCO Hayden smelter located at 866 N. Hayden Avenue, Hayden, Gila County, Arizona 85135. The mailing address for the facility is P. O. Box 8, Hayden, AZ 85135. The facility is subject to the requirements of the Federal Clean Air Act, Code of Federal Regulations, Arizona Revised Statute 49-426, and the Arizona Administrative Code, Title 18, Chapter 2. The facility emits the following air contaminants: particulate matter, nitrogen oxides, sulfur dioxide, volatile organic compounds, carbon monoxide and hazardous air pollutants.

You have an opportunity to submit written comments on the permit revision and make oral comments on the permit revision at the public hearing. ADEQ will be holding a public hearing on Monday, October 16, 2017, at 6:00 p.m. at the Hayden Senior Center, 520 Velasco Ave., Hayden, AZ 85135. The written comment shall include the name, mailing address, signature of commenter and/or their agent or attorney and shall clearly set forth reasons why the permit should or should not be issued. Grounds for comment are limited to whether the permit revision meets the criteria for issuance spelled out in the state air pollution control laws or rules.

The draft permit revision and related documentation are available for review Monday through Friday between 8:30 a.m. and 4:30 p.m., at the [ADEQ Records Center](#), at 1110 West Washington Street, Phoenix, Arizona. Please call (602) 771-4380 or email recordscenter@azdeq.gov 48 hours in advance to schedule an appointment to review the file. The documents are also available at Town of Hayden, Town Clerks' Office at 520 Velasco Avenue in Hayden, AZ 85135. The draft permit and technical support document may be viewed online at www.azdeq.gov by accessing the notice on the Events and Notices Calendar for the date of this public notice. The public notice period is in effect from September 13, 2017 to October 16, 2017. Persons wishing to submit written comments can also do so at the public hearing. Comments must be received by October 16, 2017.

ADEQ will consider all comments received in making a final decision on the proposed permit revision. Everyone commenting will receive notification of the final decision. People who file comments on the permit revision will have the right to appeal the final decision as an appealable agency action to the Office of Administrative Hearing (OAH) pursuant to §41.1092.03, and the appeal must be filed within thirty (30) days after the issuance of the final decision. The OAH may sustain, modify, or reverse the final decision.

ADEQ will take reasonable measures to provide access to department services to individuals with limited ability to speak, write, or understand English and/or to those with disabilities.
