

**PROPOSED ARIZONA POLLUTANT DISCHARGE ELIMINATION SYSTEM (AZPDES)
RENEWAL PERMIT**

Pursuant to the Clean Water Act and in accordance with Arizona Administrative Code (A.A.C.) R18-9-A907, the Director of the Arizona Department of Environmental Quality (ADEQ) proposes to issue an Arizona Pollutant Discharge Elimination System (AZPDES) Permit to discharge pollutants to Waters of the United States to the following applicant, subject to certain effluent limitations and special conditions:

The Entrada del Oro Sewer Company applied for a renewal AZPDES permit for the proposed discharge of up to 0.3 million gallons per day (mgd) of treated domestic wastewater from the Entrada del Oro Wastewater Treatment Plant (WWTP) to a tributary of Queen Creek in the Middle Gila River Basin in Township 1S, Range 10E, Section 30, in Pinal County, Arizona. The Entrada del Oro WWTP is a privately owned treatment works that receives domestic wastewater from residential and commercial sources in Gold Canyon. Sludge is sent to the Gold Canyon WWTP for further treatment and dewatering before being sent to Butterfield Landfill for final disposal.

Persons may submit comments or request a public hearing on the proposed action in writing, to Richard Mendolia, Arizona Department of Environmental Quality, Water Quality Division, 1110 W. Washington St., Phoenix, Arizona 85007, or electronically to rjm@azdeq.gov. All written comments received by ADEQ by the close of business on the date 30 days after publication of this notice will be considered in the final permit decision. A public hearing request must be in writing and must include the reasons for such request. If there is a significant degree of public interest, the Director will hold a hearing in accordance with A.A.C. R18-9-A908(B).

ADEQ will take reasonable measures to provide access to department services to individuals with limited ability to speak, write, or understand English and/or to those with disabilities.
