

**PROPOSED ARIZONA POLLUTANT DISCHARGE ELIMINATION SYSTEM (AZPDES)
RENEWAL PERMIT**

Pursuant to the Clean Water Act and in accordance with Arizona Administrative Code (A.A.C.) R18-9-A907, the Director of the Arizona Department of Environmental Quality (ADEQ) proposes to issue an Arizona Pollutant Discharge Elimination System (AZPDES) Permit to discharge pollutants to Waters of the United States to the following applicant, subject to certain effluent limitations and special conditions:

EPCOR Water applied for a renewal AZPDES permit for the proposed discharge of treated groundwater from the Miller Road Treatment Facility to the Arizona Canal in the Middle Gila River Basin in Township 2N, Range 4E, Section 14, in Maricopa County, Arizona. The Miller Road Treatment Facility is a groundwater remediation facility that was constructed to pump and treat groundwater with elevated levels of volatile organic compounds in Scottsdale.

Persons may submit comments or request a public hearing on the proposed action in writing, to Richard Mendolia, Arizona Department of Environmental Quality, Water Quality Division, 1110 W. Washington St., Phoenix, Arizona 85007, or electronically to rjm@azdeq.gov. All written comments received by ADEQ by the close of business on the date 30 days after publication of this notice will be considered in the final permit decision. A public hearing request must be in writing and must include the reasons for such request. If there is a significant degree of public interest, the Director will hold a hearing in accordance with A.A.C. R18-9-A908(B).

ADEQ will take reasonable measures to provide access to department services to individuals with limited ability to speak, write, or understand English and/or to those with disabilities.
