Title 18, Article 9.

The written comment must include the name, mailing address, and signature of commenter and/or their agent or attorney, and must clearly set forth reasons why the permit should or should not be issued. Grounds for comment are limited to whether the Notice of Intent meets the criteria for issuance spelled out in the (AZPDES) Small MS4 General Permit (AZG2016-002).
