NOTICE OF 60-DAY PUBLIC COMMENT PERIOD HIGHWAY 260 AND JOHNSON LANE WATER QUALITY ASSURANCE REVOLVING FUND (WQARF) SITE DRAFT REMEDIAL INVESTIGATION (RI) REPORT SOLICITATION OF REMEDIAL OBJECTIVES (RO)

The Arizona Department of Environmental Quality (ADEQ) has released the draft remedial investigation (RI) report for the Highway 260 and Johnson Lane Water Quality Assurance Revolving Fund (WQARF) site in Navajo County, [Arizona Administrative Code R18-16-404 (c)(1)(b)]. An RI is conducted to document the nature and extent of the contamination and the sources thereof; identify current and potential impacts to public health, welfare, and the environment; identify current and reasonably foreseeable uses of land and waters of the state; and obtain and evaluate any other information necessary for identification and comparison of alternative remedial actions. Proposed remedial objectives (RO) are solicited from the public and are the clean-up goals determined for a specific site and consider the current and reasonably foreseeable future uses of land and waters of the state.

The Highway 260 and Johnson Lane WQARF site consists of a plume located in Pinetop-Lakeside, AZ. The plume is bounded approximately by Jackson Lane to the north, Burke Lane to the south, Woodland Road to the east, and Rainbow View Drive to the west. The contaminant of concern at the site is Tetrachloroethene (PCE).

Additionally, a Community Advisory Board meeting will be held on November 14, 2018, starting at 5:30 pm, at the Timber Mesa Fire Department Building, 2922 W White Mountain Blvd. Lakeside, AZ 85929, during which all interested parties will be given an opportunity to comment on the draft RI report and provide input on the RO. All comments received will be compiled in a responsiveness summary to be included in the final RI report. Comments must be postmarked no later than November 27, 2018.
