

**PROPOSED ARIZONA POLLUTANT DISCHARGE ELIMINATION SYSTEM (AZPDES)  
RENEWAL PERMIT**

Pursuant to the Clean Water Act and in accordance with Arizona Administrative Code (A.A.C.) R18-9-A907, the Director of the Arizona Department of Environmental Quality (ADEQ) proposes to issue an Arizona Pollutant Discharge Elimination System (AZPDES) Permit to discharge pollutants to Waters of the United States to the following applicant, subject to certain effluent limitations and special conditions:

The Town of Jerome applied for a renewal AZPDES permit for the proposed discharge of up to 0.07 million gallons per day (mgd) of treated domestic wastewater from the Town of Jerome Wastewater Treatment Plant (WWTP) to Bitter Creek, a tributary of the Verde River, in the Verde River Basin in Township 16 N, Range 2 E, Section 23, in Yavapai County, Arizona. The Town of Jerome WWTP is a publicly owned treatment works that receives domestic wastewater from residential and commercial sources in Jerome. Dewatered sludge is hauled to an approved landfill for disposal.

Persons may submit comments or request a public hearing on the proposed action in writing, to Ramona Chomor, Arizona Department of Environmental Quality, Water Quality Division, 1110 W. Washington St., Phoenix, Arizona 85007, or to [rc7@azdeq.gov](mailto:rc7@azdeq.gov). All written comments received by ADEQ by the close of business on the date 30 days after publication of this notice will be considered in the final permit decision. A public hearing request must be in writing and must include the reasons for such request. If there is a significant degree of public interest, the Director will hold a hearing in accordance with A.A.C. R18-9-A908(B).
