ARIZONA DEPARTMENT OF ENVIRONMENTAL QUALITY STATE IMPLEMENTATION PLAN REVISION PUBLIC COMMENT AND HEARING

The Arizona Department of Environmental Quality welcomes comments on the proposed inclusion of the revised statewide statute and rules for Agricultural Best Management Practices (AgBMP) located at Arizona Revised Statutes § 49-457 and Arizona Administrative Code, Title 18, Chapter 2, Article 6 into the Arizona State Implementation Plan. The rule update fulfills commitments made in the Draft 2022 Serious Area Particulate Plan for PM-10 for the West Pinal County Nonattainment Area and demonstrates that the State of Arizona and Maricopa Association of Governments have the necessary programs to attain the National Ambient Air Quality Standard (NAAQS) for coarse particulate matter (PM-10) in the West Pinal Nonattainment Area by December 31, 2026. The revised AgBMP statute and rules will be submitted to the U.S. Environmental Protection Agency for inclusion into the Arizona State Implementation Plan.

Comments will be accepted until January 23, 2023. Comments may be mailed or emailed to Laura Mirtich, Air Quality Division, Arizona Department of Environmental Quality, 1110 W.
