The Air Quality Division of the Arizona Department of Environmental Quality (ADEQ) welcomes comments on the proposed *Arizona State Implementation Plan (SIP) Revision: Air Quality Control Rules Clarification*. These final rule revisions improved consistency in language between state and federal regulations and eliminated requirements no longer necessary for the operation of state government. The *Air Quality Control Rules Clarification* final rule revisions will now be submitted to the U.S. Environmental Protection Agency (EPA) for federal approval and incorporation as a revision to the Arizona SIP as required under the Clean Air Act.

This public notice provides information to help you participate in the decision-making process. You have an opportunity to submit written comments about this SIP revision. Comments on the proposed SIP revision will be accepted until Wednesday, January 22, 2025 by 5:00 PM Arizona time.
