

**NOTICE OF AVAILABILITY AND 45-DAY PUBLIC COMMENT PERIOD
ADAIR MEMORIAL PARK
VOLUNTARY REMEDIATION PROGRAM (VRP) SITE
CONDITIONAL NO FURTHER ACTION DETERMINATION**

Yuma County Department of Public Works has submitted a request for a Conditional No Further Action (CNFA) determination to the Arizona Department of Environmental Quality (ADEQ) Voluntary Remediation Program (VRP) for the Adair Memorial Park Archery Range (VRP Site Code 505354-00) VRP site (the Site). The CNFA requests closure for soil and was submitted in accordance with Arizona Revised Statutes §§ 49-176 and 49-181.

The Site covers approximately 24 acres on property owned by Yuma County, located in Yuma, Arizona. The Site is currently used as an archery range. The site once contained a silver ore processing facility. Contaminant of concern are lead residues in soil that was used in the processed historic ore tailing that were discarded on site.

The CNFA requests closure for soil by using institutional and engineering controls defined in a forthcoming Declaration of Environmental Use Restriction. The CNFA was submitted in accordance with Arizona Revised Statutes §§ 49-176 and 49-181.
