NOTICE OF 30-DAY PUBLIC COMMENT PERIOD CAT MOUNTAIN VISTA VOLUNTARY REMEDIATION PROGRAM SITE REQUEST FOR NO FURTHER ACTION DETERMINATION

Seymour Family LLC has submitted a request for a No Further Action (NFA) determination to the Arizona Department of Environmental Quality (ADEQ) Voluntary Remediation Program (VRP) for the Cat Mountain Vista VRP site. The NFA requests closure for soil was submitted in accordance with Arizona Revised Statutes § 49-181.

The Cat Mountain Vista VRP site consists of an 8.32 acre area with soil from excavations and removal of debris located in an unincorporated area covering approximately near Tucson, Arizona. The site had buried solid waste debris that has been excavated and removed from the site. Contaminants of concern at the site consist of arsenic in the soil. Arsenic levels have been determined to be representative of natural background concentrations such that no further remedial action is warranted at the site.
