## NOTICE OF 45-DAY PUBLIC COMMENT PERIOD HVF WEST, LLC VOLUNTARY REMEDIATION PROGRAM SITE REOUEST FOR CONDITIONAL NO FURTHER ACTION DETERMINATION

HVF West, LLC has submitted a request for a Conditional No Further Action (CNFA) determination to the Arizona Department of Environmental Quality (ADEQ) Voluntary Remediation Program (VRP) for the HVF West, LLC VRP site. The CNFA requests closure for soil by using an Institutional Control Declaration of Environmental Use Restriction (DEUR). The CNFA was submitted in accordance with Arizona Revised Statutes § 49-181.

The HVF West, LLC VRP site consists of approximately 31 acres in an industrial area south of Davis-Monthan Air Force Base in Tucson, Arizona that has been and is currently operated as an aircraft salvage and recycling facility. HVF West, LLC specializes in the demilitarization of military material to United States Department of Defense specifications. The Institutional Control will restrict the property to non-residential use. Contaminants of concern at the site are cadmium, chromium, lead, and mercury in soil.
