

**NOTICE OF 30-DAY PUBLIC COMMENT PERIOD
MISSION LINEN SUPPLY
VOLUNTARY REMEDIATION PROGRAM SITE
REQUEST FOR SOIL NO FURTHER ACTION DETERMINATION**

Mission Linen Supply (Mission) has submitted a request for a No Further Action (NFA) determination to the Arizona Department of Environmental Quality (ADEQ) Voluntary Remediation Program (VRP) for the Mission Linen Supply VRP site. The NFA requests closure for soil and was submitted in accordance with Arizona Revised Statutes § 49-181.

The Mission Linen Supply VRP site consists of an approximately 0.5-acre property located at 621 South 1st Avenue in Phoenix, Arizona. A Vapor Intrusion Assessment evaluated the risk to future residents, commercial/industrial workers, and construction workers due to residual concentrations of chlorinated solvents in soil and soil vapor at the site.
