

**NOTICE OF 30-DAY PUBLIC COMMENT PERIOD  
MORENCI SCHOOLS SITE  
VOLUNTARY REMEDIATION PROGRAM SITE  
REQUEST FOR NO FURTHER ACTION DETERMINATION**

Freeport Minerals Corporation has submitted a request for a No Further Action (NFA) determination to the Arizona Department of Environmental Quality (ADEQ) Voluntary Remediation Program (VRP) for the Morenci Schools VRP site. The NFA requests closure for soil and was submitted in accordance with Arizona Revised Statutes § 49-181.

The Morenci Schools VRP site consists of 72 acres and is comprised of an elementary, middle, and high school in addition to school district administration buildings, bus barn, parking lots, play areas, and sports fields located in Morenci, Arizona. Contaminants of concern at the site are metals in soil.
