## Notice of Extension of 90-Day Comment Period

Proposed Remedial Action Plan  
East Central Phoenix 48<sup>th</sup> St and Indian School Road  
Water Quality Assurance Revolving Fund Site

The Arizona Department of Environmental Quality (ADEQ) is extending the public comment period for the Proposed Remedial Action Plan (PRAP) for the East Central Phoenix 48<sup>th</sup> Street and Indian School Road Water Quality Assurance Revolving Fund Site (Site) in Phoenix, AZ for an additional 17 days until November 22, 2024 [Arizona Administrative Code R18-16-408(C)]. The PRAP documents the Remedial Investigation/Feasibility Study (RI/FS) results, identifies the proposed remedy and estimates the cost of the remedy. The PRAP public comment period started on **August 8, 2024** and will end on **November 22, 2024**.

The Site contains contaminated groundwater. The contaminant of concern is tetrachloroethene. The approximate Site boundaries are Devonshire Avenue to the north, Weldon Avenue to the south, 48th Street to the east, and 42<sup>nd</sup> Street to the west in Phoenix.

The proposed remedy for the Site includes: Monitored Natural Attenuation. Contingencies include downgradient well installation and three additional years of monitoring. The estimated cost to implement the remedy is approximately \$2,766,000 over 18 years.
