

The Voluntary Vehicle Repair Program (VVRP) pays up to \$900 toward the cost of emissions-related vehicle repairs after a failed emissions test. Customers must meet program requirements and pay a \$100 co-pay toward repairs. All repairs must be performed through a VVRP Approved Repair Facility and that facility bills directly to Gordon-Darby Arizona Testing (GDAT) for the cost of repairs approved by VVRP.

Benefits becoming a VVRP Approved Repair Facility include:

How to Become a VVRP Approved Repair Facility

Step 1 | Determine whether your facility meets all the following requirements:

- Employ at least one current ASE certified technician in the following:
 - Advanced Engine Performance Specialist (L1)
 - Master Certification (A1) through (A8)
 - A combination of (A1), (A6) and (A8) Certifications

**Scanned copies of current ASE Technician certification must be attached to this application at the time of submission*

- Maintain diagnostic and repair equipment necessary to return all program eligible vehicles to compliance on a continuing basis
- Must utilize the most current release of Mitchell 1 Manager/Manager Plus and/or On Demand 5 Estimator vehicle repair industry software to ensure standardized repair estimates and invoicing in order to assist in monitoring labor hours/cost and parts pricing
- Must have internet access and scanner/printer capabilities
- Preferred (but not required) to maintain a 90% or better repair efficiency

Step 2 | Complete a VVRP Approved Repair Facility application

Step 3 | Schedule an on-site inspection

- 1) ADEQ will contact you to schedule an on-site inspection within 7 business days, which will determine if your repair facility is qualified for VVRP.
- 2) After the inspection and if your repair facility is accepted into VVRP, ADEQ will provide you with a User Guide that has step-by-step instructions on how to bill repairs back to Gordon-Darby Arizona Testing (GDAT) and process program paperwork.

ADDITIONAL IMPORTANT INFORMATION

If after you have completed your repairs on the vehicle and the vehicle fails the emission retest for the original factors contributing to the vehicle's initial failure of the emissions inspection, your repair shop shall cover the cost of any emissions repairs necessary to get the vehicle to a passing result.
