### Record of Decision

### Park-Euclid Water Quality Assurance Revolving Fund Site

The Arizona Department of Environmental Quality (ADEQ) issued the Record of Decision for the Park-Euclid Water Quality Assurance Revolving Fund site (Site) in Tucson, Arizona. The Record of Decision is the final legal document that describes the Site's selected remedy, a schedule and estimated cost to implement the remedy, and a response to all public comments on the Site's Proposed Remedial Action Plan.<sup>1</sup>

The Site contains contaminated groundwater and soil vapor. Contaminants of concern are tetrachloroethene (PCE), trichloroethene (TCE), *cis*-1,2-dichloroethene (*cis*-1,2-DCE), *trans*-1,2-dichloroethene (*trans*-1,2-DCE), and vinyl chloride. The approximate Site boundaries are 9<sup>th</sup> Street to the north, 14<sup>th</sup> Street to the south, Mountain Avenue to the east, and Euclid Avenue to the west in Tucson.
