WATER QUALITY ASSURANCE REVOLVING FUND (WQARF) REGISTRY SITE

Misael Cabrera, Director of the Arizona Department of Environmental Quality ("ADEQ" or "State") announces a settlement agreement with Osborn Products, Inc. ("Osborn") a Potentially Responsible Party within the West Central Phoenix – North Canal Plume WQARF Registry Site ("Site") in Phoenix, Arizona. The Site is approximately bounded by Indian School Road on the north, West Flower Street on the south, Grand Avenue on the east and 41st Avenue on the west.

Osborn submitted a request for a Qualified Business Settlement to ADEQ pursuant to Arizona Revised Statutes (A.R.S) § 49-292.01. ADEQ has conditionally accepted the offer of settlement, pending review and evaluation of public comments submitted as a result of this notice.

ADEQ electronically docketed the Qualified Business Settlement document entitled State of Arizona, Misael Cabrera, Director, of the Arizona Department of Environmental Quality and Osborn Products Inc., an Arizona corporation. The Qualified Business Settlement confirms settlement of any and all of the State's claims as against Osborn under Section 107 of the Comprehensive Environmental Response, Compensation and Liability Act of 1980, as amended ("CERCLA"), 42 U.S.C. Sec. 9601 *et seq.* and the Water Quality Assurance Revolving Fund, A.R.S. § 49-281 *et seq.* in connection with the Site.
