Statewide Water Quality Management Working Group

Proposed 208 amendments for new or significantly changed wastewater are reviewed at meetings of the Statewide Water Quality Management Working Group. The committee typically reviews treatment facilities located throughout the state. After each 208 amendment presentation, the group provides comments and forwards them to the Arizona Department of Environmental Quality AZPDES Individual Permits Unit for additional review and approval. The group has educational presentations by agencies or individuals on water quality issues and on agency procedures for project approvals.
