<b>Purpose and Authority:</b>			
<p>The Water Quality Management Working Group (WQMWG) is an advisory committee to the Arizona Department of Environmental Quality Surface Water Permits Unit. The Working Group reviews and recommends a course of action on Areawide Water Quality Management plans and amendments and thereby assists in statewide compliance with Section 208 of the Clean Water Act. The WQMWG does not have the authority to deny a 208 amendment, but it may alert ADEQ staff to amendment deficiencies.</p> <p>The WQMWG also provides a forum for communication between Working Group members and ADEQ staff to ensure statewide coordination and information dissemination. The meetings also may be used as a vehicle for member training.</p>

<b>Quorum:</b> A majority of voting members must be represented either in person, or via conference call, to establish a quorum. Either Members or their alternates may constitute representation.			
<b>Voting:</b> Each DPA may have one vote. Proxy voting is not allowed, except by designated alternate. Voting may occur via conference call or, on rare occasions, by email.			
<b>Public Comment:</b> Public comment may be offered during the Call to the Audience or on comment cards provided at the meetings. At the discretion of the chair, the public also may participate in the discussion on each agenda item. If necessary, the chair may limit the time allocated for comment to three minutes per person.			
<b>Meeting Schedule:</b> When scheduled, meetings, are typically held on the second Tuesday of even numbered months (February, April, June, August, October, and December). Meetings are generally held at the AZ. Department of Environmental Quality, 1110 W. Washington Street, Phoenix, Arizona, at 10:00 a.m.			
<b>Meeting Minutes:</b> Minutes are recorded and available within three working days of the meeting. Summary minutes are written for each meeting and are distributed one week prior to the next meeting.
